PRESIDENT'S REMARKS

he WPPOA annual meeting of September 11, 2012 has come and gone, leaving us with the election of three board members. Pat Shippey was re-elected for a second term. Pat's contribution as treasurer has been outstanding and will add continuity to the treasurer position. Larry Wittenmyer and Jerry Hughson were elected to fill the remaining two vacancies. We want to welcome Larry and Jerry to the board. They both bring a wealth of experience that will be an asset to the WPPOA.

The WPPOA board extends its thanks for a job well done to the departing members Bill Bower and Bob McCann. They will be missed and we wish them the best.

On September 12, 2012, Melanie Brock and I attended the latest SCDOT update of the Silver Bluff widening project. Very little has changed since the last update. They seem to be ready to proceed with final plans for the road to be widened from Richardson Lake Road to Indian Creek Trail. This will provide for two driving lanes with a median and turn lanes. Some additional right of way will be required. We have requested a meeting with SCDOT to determine what effect this will have to our main entrance. Hopefully, there will be very little impact. My guess is that nothing will happen with this project prior to 2014.

You may have noticed the motorcycle storage facility built by Woodside Development Company has been completed. It looks good and is now operational. We are told that most of the area available is now occupied. Thanks for the understanding and cooperation of all concerned parties.

C.E.E.C. (COVENANTS)

What's good for the Goose is not necessarily good for the Gander

Well, the proposed amendment to implement a very limited control over lease/rental agreements failed to pass by 1.5% of the votes cast.

As I stated in my prior newsletter, the intent of the failed amendment was to protect the aesthetic and economic interests of the community at large and specifically, to protect the property owners surrounding a residence which is in constant violation of the Covenants by giving the POA another avenue for protecting those property owners' interests.

Basically what was being proposed in the amendment was to insure that:

- 1. Lease/Rental Agreements were to be for a period not less than 6 months
- 2. Only one family could occupy a lease /rental property
- 3. The lessor provide the lessee with a copy of our Covenants
- 4. When the lessor failed to resolve a Covenant violation, the POA would have the authority to interact directly with the tenant.

In all cases, the POA Board would have had the authority to exercise discretion in those cases where conditions/events might impose an undue burden on the lessor.

No Good Deed Goes Unpunished

And as you can probably guess, the first complaint the POA received after the Annual Meeting was a Covenant violation from the occupant of a rental property – more than likely due to the lessee not having knowledge of our Covenants.

If the Board can be convinced to do so, the proposed Lease/Rental Amendment to our Covenants will be on the 2013 Annual Meeting Agenda. See y'all next month!

COMMON AREA LANDSCAPING

Screening for Landscapes and Hardscapes

It seems as though our home landscaping plantings either flourish or flounder depending on Mother Nature. Since fall is a great time to plant, we felt a review of our guidelines' requirements for screenings would be appropriate.

Whether you are just building or are evaluating your current home site for upkeep, the guidelines suggest open areas under porches, decks and carports must be properly screened on all sides. The ARB's recommended screening for decks and porches is with wood lattice or other approved material that is compatible with the house color. It is further recommended that mature plantings be added for a quality look. The ARB, at its sole discretion, may allow homes built on home sites with steep grades to have open space under the rear decking; however, no storage will be permitted within these unscreened areas.

All pool equipment, hot tubs and Jacuzzis must be screened completely from view... that includes the neighbors, the golf courses, the street and the public.

Satellite dishes must have their supporting poles screened with buffer plantings such as spreading evergreens to minimize the impact of the dish's height.

HVAC units are to be adequately screened. Lattice, brick or other appropriate materials compatible with the exterior of the homes may be used instead of plants. Plants can be smaller if lattice is in place. The preference is to have both. If plants are used for screening they must be of substantial size and variety that they will adequately screen the HVAC completely in one year.

Utilities and meters on or close to the structure must be screened from the street and golf course but not necessarily from the neighbor. This is due to a utilities requirement to be able to read the meter.

Service areas for heat pumps, air conditioning compressors, or other miscellaneous storage should be adequately screened and located as remote from adjacent properties as possible. Moreover, service yards for trash receptacles are to be screened on two sides and must have a gate to fully enclose the area. Architectural screening of such elements should be totally integrated with the design of the residence.

Let's make sure our screenings are doing their job. If your plantings meant for screening are not adequate, consider replacing them with more mature, healthy and attractive ones.

TREASURER'S REPORT

Some Good News

Total income through the end of September exceeds by \$6,600 the total annual budgeted income.

- The decrease in interest income is being offset by increases in decal and barcode sales. (It must be due to those new cars you see your neighbors driving!)
- Expenses in all categories continue to be under budget.
- The excess revenue has allowed us to cover the cost of this year's portion of the four year landscaping strategic plan and the digitization of all ARB plans without having to dip into the undesignated reserve accounts.

A new survey of CD rates offered by the banking institutions in the CSRA was recently completed as our two remaining CD's are maturing in November and December. The current published rates would require investing in a three year CD to get the same rate as a money market account. With significant road repairs looming in the next couple of years, reserve funds need to remain more liquid. We will continue to monitor the rates as the maturity dates get closer.

Halloween Safety

Universal Protections Services shares with us the following safety tips for keeping little ones safe this Halloween. Following these steps can help ensure everyone has a fun and exciting holiday.

• Make sure children's costumes are flame retardant and provide adequate vision. If they're carrying props, check that the edges are flexible enough to avoid injuries.

• Have an adult or responsible teen accompany children. If they're going without you, ensure they're traveling with a group and agree on a time for them to return home. Provide a watch for them to wear to keep track of the time.

• Fill kids up with dinner before they leave, which will make them less likely to snack on their candy before you have a chance to look it over.

• Give children a flashlight to carry and instruct them to approach only houses with lit porch lights. Consider having them take along an I.D., which includes their home address

and telephone number.

• Apply reflective tape to children's costumes and bags. You might also want to consider glow-in-the-dark makeup.

• Remind children to stay on sidewalks, walk facing traffic and never cross the street between parked cars.

• Be careful with the little ones when carving pumpkins. Small children should never handle knives but they can get involved in the fun by drawing a face on the pumpkin or scooping out the insides.

• Use caution while driving – stay alert and watch for children running in the street.

• If you plan to display pumpkins or candles in the area where you'll be handing out candy, set them far enough out of the way to avoid fire or injury.

• Explain to children the difference between tricks and vandalism. Throwing eggs at a house may seem like fun at the time, but they need to understand the consequences that causing such damage will cost themselves or their parents.
